Jr. SUPERVISOR

John Lyons reported he is foremost, privileged to have been appointed to the position of junior township supervisor. He is eager to represent my school and familiarize myself with local governance and policy. Rustin High School is approaching the end of its second marking period for the 2021-2022 school year, marking the conclusion to another semester of adapting, adjusting, and in some cases, returning to pre-pandemic normalcy. The month of December ended with Rustin's first Social Emotional Learning Day, where students could select from multiple activities, all run by the faculty, meant to stimulate social interaction and break the monotony of traditional school days. This is a part of a larger undertaking to better accommodate students and account for the strains on mental health that the pandemic brought about. The boys' junior varsity basketball team stands at 5-1 and varsity reports 3-3 as of today. The career-counseling department hosted their "Becoming a Doctor" career future seminar, where students with medical aptitudes could participate in a questionnaire with university medical students. Additionally, the Rustin Book Club has announced is sponsoring a contest to design a book-themed t-shirt that will be offered for sale at the Rustin Spirit Store. Just before break, the Walk Her Home Club, in conjunction with the National Honors Society, ran a successful holiday fundraiser, accumulating over \$500 for the charity. - 1. We received a proposal from Mardinly to Load bank test our backup generators within the east side sewer district. This includes testing for 6 pump stations and also the treatment plant for a total cost of \$6,947.00. (AGENDA ITEM MOTION)
- 2. We are recommending approval for the following items requested by the Historical Commission:

Township Solicitor, Kenneth D. Kynett Esquire, files the following report for January 3rd, 2022:

- 1. <u>2022 Organization Meeting Requirements</u> Worked with Township Manager to answer questions regarding Township-wide (re)organization meetings.
- 2. <u>In-Law Suites Form Restrictions</u> In-law suites are permitted by special exception in certain residential districts within the Township. When approved by the Zoning Hearing Board, the approval often, if not always, requires written, recorded restrictions to be filed against the property so that it does not become a second dwelling or rental property. Following the recent approval of an in-law suite at 7 Tanguy Road, worked with the Township Manager to prepare a form of Restrictive Covenant to be completed by property owners for recording to help ensure that this task gets completed in order to allow a zoning permit or certificate of occupancy to be issued for the in-law suite.
- 3. <u>Guilday Creek Road Subdivision</u> Revised Deeds of Dedication and related documents to separate those in public right-of-way from those on private property. This will allow dedication to occur in stages with those sewer facilities in the public rights-of-way of Creek and Old Gradyville Roads to be dedicated by the Developer. This will avoid the anticipated delay in dedication caused by a development field change which altered the approved location of a shared 2" force main on Lot 1 and Lot 5.
- O'Kane Land Development Application 15 Tanguy Road Prepared draft resolution for Preliminary/Final Land Development, pending compliance with Historical Commission review and recommendation.



REPORT OF THE ENGINEER January Supervisor's Regular Meeting January 3, 2022

Work completed for the period:

Grading and Road Encroachment Permits – Reviewed several plans for grading and road encroachment. Construction inspections continue.

Planning Commission – Continued working with members on Ordinances and Subdivisions.

Subdivision & Land Development Plans:

Lawler Subdivision - Awaiting revised plans.

Daniels Subdivision – 425 Thornton Rd – 2 Lots – Conditional Final approval granted in 2016. Awaiting updated recording plans and agreements for signature.

15 Tanguy Road – 2,400 SF Accessory Structure Land Development – Review letter issued for revised plans and reviewed with Planning Commission at their November meeting. Planning Commission recommended conditional approval of the plans.

VMDT – Dilworthtown Road – Subdivision / Land Development submission review letter issued and reviewed with Planning Commission at their November Meeting. Planning Commission tabled review until engineering and legal items identified in the review letter could be addressed.

Ordinances:

Sign Ordinance – PC forwarded ordinance to the Supervisors for consideration.

Plant Materials List – Reviewed current Township Ordinance Plant Materials List and issued our Landscape Architect's recommendations for exclusions due to local blights and diseases. Reviewed with the Planning Commission in May. PC forwarded list changes to the Supervisors for consideration.

Crane Property – 24 Lot Subdivision – All 24 homes are now occupied. Review of conversion of existing temporary CO's to Permanent CO's are ongoing.

Black Bell Farm (Walton Lane) – 15 lot subdivision – Lots 1-14 (All new homes) are now occupied. Awaiting final correction of punch list deficiencies and final dedication and closeout paperwork. An updated inspection and punch list was sent to the developer on 9/22/21. Awaiting final punch list work completion and final dedication paperwork submission.

Guilday Site – Lots 1-5 houses are occupied with Temporary CO's. Request for final inspection received in June and a Final Punch list was issued to the developer on 7-15-2021. Awaiting corrections and closeout paperwork.

Sunoco Logistics – Sunoco has completed all piping and valve work. Awaiting NPDES Permit Amendment, final restoration and request for final inspection.

NPDES MS-4 Program – 2018 Pollutant Reduction Plan and 2018 MS-4 permit submitted on September 9, 2017 & September 15, 2017, respectively. Continuing to work with PA DEP on revisions. Detailed updates to the storm sewer and qualifying watershed mapping has been completed to comply with revision requests from PA DEP. Program is currently under Township review prior to resubmission of mapping.

Thornbury Park Rain Garden – Water Quality Improvement Project Grant – PA DEP Grant work must be completed by December 31, 2021. Project is substantially complete. Final sign design sent to the Township for approval prior to final manufacture. Township has sent to sign consultant for update prior to submission for manufacture.

Thornbury Pre-School Roof Replacement – Draft plans prepared for slate or synthetic slate alternate bidding. Submitted to Township officials for review and comment.

Terra Firma Builders – 53-57 Sweetwater Road – At the request of the developer, a final inspection was performed and a punch list letter was issued on 12/13/21. Awaiting corrections and closeout paperwork prior to final escrow release.

Township Map Update – Completed map update with the help of Township officials. Working on obtaining large plots for framing and hanging in the Municipal Building.

Salt Shed Structural Evaluation – Coordination ongoing with Township Roadmaster and structural engineer for the structural evaluation of the Township Salt Shed in Thornbury Park.

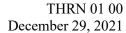
2021 Road Program – All items completed, and final payment made. Final project forms being completed for PA DOT closeout.

2021 Additional Paving Projects – All items completed, and final payment made for project closeout.

Various Drainage Improvement Projects – Prepared sketch plans and began discussion with Township officials on various drainage improvement projects throughout the Township.

• Judith Lane Drainage Improvements Pre-Application Meeting - Met PA DEP and reviewed alternatives. Wetland delineation has been completed in the field. Awaiting wetland report.

Brinton Lake Private Roadways – Research and measurements being taken to analyze cost estimates for updating and repaving the community roadways.





ENGINEER'S REPORT REGARDING WASTEWATER ISSUES January 3, 2022

East Side District

- Wet Weather Flows to WWTP

• We anticipate having a bid package together within the next 2-weeks for the repairs to those components of the system that were identified during the television inspection and smoke testing. The work will consist of addressing leaks identified at various manholes, re-sealing of various castings, and the installation of manhole inserts. The two areas of this work will be the easement area behind Strickland Road properties and the Country Run easement.

- Black Bell Farm

 The remaining punch list item for this development are the revisions to the as-built plans to adequately depict the location of the new main. We again notified the developer of these remaining items.

- Isabella Lane Sanitary Sewer

• A notice of award with Contract documents were forwarded to Botella Construction on December 23rd. We will follow up with Botella to execute the contracts so construction can commence as soon as materials are procured (and weather permits).

- Guilday Subdivision

• Final easement drawings/descriptions for the 2-inch low-pressure sewer line on 258 & 262 Old Gradyville Road have been forwarded to the Solicitor and Township.

- Meredith Circle Pump Station

• The new generator for the station was ordered on December 20th. The estimated delivery time is at least 5 to 6-months and potentially could be longer should the supply chain issues persist.

West Side District

- Low Pressure Force Main flushing

• KBX Golden/Windriver Environmental Company completed the flushing of the low-pressure force mains in Brinton Lea and Thornhill sections of the Township on December 22nd. The process went well, no issues were encountered. A few minor repairs were noted and will be addressed as soon as possible.
