The Thornbury Township Board of Supervisors held a Public Meeting, Wednesday May 18, 2022, at the Township Administration Building, 6 Township Drive, Cheyney PA. Chairman Kelly called the meeting to order at 7:00 p.m. with a salute to the flag.

AGENDA ITEMS

Ken Kynett detailed the Recreation and Education Access Easement requirements.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, the Recreation and Education Access Easement by and between New Brinton Lake Club and Thornbury Township, as detailed in the April 21, 2022 draft, subject to receipt and approval of the easement description and plan which are to be attached to the Access Easement Agreement as Exhibits, was approved. Chairman Kelly called for comment. There was no comment.

Jeff Seagraves reported for Charles Faulkner on the Manhole Rehabilitation Contract.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, awarding the Manhole Rehabilitation Contract Base Bid plus all Alternates, to Advanced Rehabilitation Technology, in the amount of \$107,453.00, contingent upon their execution of the contract and supply of the required bonds and insurance, as detailed in the Township Sewer Engineer's Recommendation Letter dated May 13, 2022, was approved. Chairman Kelly called for comment. There was no comment.

Art Risley reported on the tree maintenance Proposal from Knight Brothers.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, the Open Space Maintenance proposal from Knight Brothers, for tree removal located at Mill and Creek Roads, at a cost not to exceed \$10,040.00, as specified in their quote #8924 dated May 4, 2022, was approved. Chairman Kelly called for comment. There was no comment.

Jeff Seagraves reported on the continued updates to the Township Comprehensive Plan.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, the Work Service Agreement Extension for the Thornbury Township Comprehensive Plan Update at a cost not to exceed \$10,965.40, as specified in the Delaware County Planning Department's proposal from May, 2022, was approved. Chairman Kelly called for comment. There was none.

Jeff Seagraves reported on the recent purchase of a turbidity meter.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, ratifying the purchase of a Turbidity Meter from DELCORA, under COSTARS Contract # 020-002, at a cost not to exceed \$8,035.53, as detailed in their proposal dated May 6, 2022, was approved. Chairman Kelly called for comment. There was no comment.

Jeff Seagraves reported on the 2022 Summer Camp Hires.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, three part-time summer hires, Kelly Daudert, Jeremiah Daudert and Andrew Lawrence as camp counselors for the 2022 summer camp season, was approved. Chairman Kelly called for comment. There was no comment.

Jeff Seagraves reported on the Lawlor Subdivision Extension.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, the extension for the Lawlor Subdivision from May 27, to August 25, 2022, was approved. Chairman Kelly called for comment. There was no comment.

Jeff Seagraves detailed three Spring Donations.

On a motion by Mike Mattson, seconded by Sheri Perkins, and carried unanimously, the following Spring Donations; \$250.00 to the Hickory Springs Animal Shelter for the recent placement of a stray dog, \$500.00 to the Delaware County Veterans Museum for Memorial Day and \$1,050.00 to the Western Del-Val Lions, which is \$500.00 for their Memorial Day service and \$550.00, to their Annual Golf Tournament, were approved. MANAGER'S REPORT

1. We received a proposal from Delaware County Planning Department for the additional work on the Comprehensive Plan. The original scope of work contemplated only revisions to the Comp Plan, but given the length of time that has elapsed and the incorporation of new Census statistics it seems logical to expand the work required to complete the Comprehensive Plan (MOTION).
2. We are moving forward with the Municipay proposal that was approved by the Board of supervisors. Our staff has attended training and we have ordered the materials necessary to complete the task of setup.
3. We received bids for the manhole restoration contract. We are recommending that the Board award the base bid and all of the alternates for a total contract amount of \$107,453.00 to Advanced Rehabilitation Technology. (MOTION)
4. We are recommending a contribution to the Hickory Springs animal Shelter in the amount of \$250.00. This is the shelter that took the stray that Alan Strickler delivered to the Brandywine Veterinary Hospital on April 11, 2022. (MOTION)
5. We sent a letter to the residents of Meredith Circle explaining the work that will take place to replace the generator and install natural gas to the pump station.
6. We are recommending the hiring of summer staff for our Summer Art and Recreation. (MOTION)
7. We will be holding the Public Works recognition event at Thornbury Park tomorrow, Thursday May 19th from 4:00 to 6:00. We are encouraging residents to attend to celebrate and show our gratitude to the fine work of our public works department.
8. We sent pizza dinners compliments of the Board of Supervisors to each of the fire companies that serve Thornbury Township
9. Plans for the Memorial Day Service have progressed. Representative Craig Williams will be our Keynote speaker. We recommend contributing to the Pennsylvania Veterans Museum and to the Western Del Val Lions for their help in holding this event. (MOTION)
10. We need to replace the turbidity meter at the Treatment Plant. I approved the purchase already due to supply issues and request the Board's ratification of the purchase. DELCORA provided a proposal dated May 6, 2022 in the amount of \$8,035.53, which includes the purchase as well as warranty. (MOTION)
11. We received an extension for the Lawlor subdivision taking the date from May 27, 2022 to August 25, 2022.
12. We plan to hold our June 1, 2022 Board of Supervisors meeting at Thornbury Park and request approval to advertise the change of venue, weather permitting. (MOTION)

Township Solicitor, Kenneth D. Kynett Esquire, files the following report for May 18th, 2022:

1. 434 Glen Mills Road – Researching existing drainage easement from Brinton Lea subdivision, as a follow up to meeting with property owner.
2. New Brinton Lake Club – Counsel for NBLC approved Board authorized revisions to Recreational Easement made on April 21, 2022. Easement is now in a position for Township execution if the Board so desires.
3. Outdoor Dining Ordinance – Received County Planning Commission review dated May 9, 2022. Approval was recommended with consideration of the following:
 - (a) Regulation of outdoor heaters in Section 9. N., which are general prohibitions unless allowed by the Board in the Conditional Use process; and
 - (b) Parking should be addressed, especially if it impinges on an area of required parking for the principal restaurant use.

The Board should consider if it wants any additional revisions made to the draft and should then send on to the Township Planning Commission for review (as the form has been updated), followed by scheduling of a public hearing.

May Supervisor's Work Session
May 18, 2022

Work completed for the period:

Grading and Road Encroachment Permits – Reviewed several plans for grading and road encroachment. Construction inspections continue.

Planning Commission – Continued working with members on Ordinances and Subdivisions.

Subdivision & Land Development Plans:

Lawler Subdivision - Awaiting revised plans.

Daniels Subdivision – 425 Thornton Rd – 2 Lots – Conditional Final approval granted in 2016. Awaiting updated recording plans and agreements for signature.

15 Tanguy Road – 2,400 SF Accessory Structure Land Development – Conditional Final Approval granted 2/16/22. *Revised digital plans received and under review prior to plotting for recording.*

VMDT – Dilworthtown Road – Subdivision / Land Development submission review letter issued and reviewed with Planning Commission at their November Meeting. Planning Commission tabled review until engineering and legal items identified in the review letter could be addressed. Awaiting revisions.

Ordinances:

Outdoor Dining Ordinance – Completed final review with Planning Commission at April meeting with recommendation of conditional approval.

Pa Model Stormwater Ordinance – Will need to schedule for incorporation into the current stormwater ordinance and review with the Planning Commission for adoption by 9/30/2022.

Sign Ordinance – PC forwarded ordinance to the Supervisors for consideration.

Plant Materials List – Reviewed current Township Ordinance Plant Materials List and issued our Landscape Architect's recommendations for exclusions due to local blights and diseases. Reviewed with the Planning Commission in May. PC forwarded list changes to the Supervisors for consideration.

Crane Property – 24 Lot Subdivision – All 24 homes are now occupied. Review of conversion of existing temporary CO's to Permanent CO's are ongoing.

Black Bell Farm (Walton Lane) – 15 lot subdivision – Lots 1-14 (All new homes) are now occupied. An updated inspection and punch list was sent to the developer on 4/29/22. Awaiting final punch list work completion and final dedication paperwork submission.

Guilday Site – Lots 1-5 houses are occupied with Temporary CO's. An update to final punch list was issued 1/21/22, with all site items completed. Awaiting final closeout paperwork.

Sunoco Logistics – Sunoco has completed all piping and valve work. Awaiting NPDES Permit Amendment, final restoration and request for final inspection. Awaiting Sunoco schedule for Slitting Mill Road repairs.

NPDES MS-4 Program – 2018 Pollutant Reduction Plan and 2018 MS-4 permit submitted on September 9, 2017 & September 15, 2017, respectively. Continuing to work with PA DEP on revisions. Detailed updates to the storm sewer and qualifying watershed mapping has been completed to comply with revision requests from PA DEP. Program is currently under Township review prior to re-submission of mapping.

Thornbury Pre-School Roof Replacement – Draft plans prepared for slate or synthetic slate alternate bidding. Submitted to Township officials for review and comment.

Terra Firma Builders – 53-57 Sweetwater Road – At the request of the developer, a final inspection was performed and a punch list letter was issued on 12/13/21. Site work items have been corrected. Still awaiting closeout paperwork prior to final escrow release. *Sent another reminder to developer's engineer.*

Various Drainage Improvement Projects – Prepared sketch plans and began discussion with Township officials on various drainage improvement projects throughout the Township.

- Judith Lane Drainage Improvements Pre-Application Meeting - Met PA DEP and reviewed alternatives. Wetland delineation has been completed in the field. Awaiting wetland report.

Brinton Lake Private Roadways – Performed a site visit for measurements to upgrade the private roadways. A cost estimate for roadway improvements and anticipated tree removal was forwarded to the Township for review and coordination with the Brinton Lake Community. Existing right of way research is ongoing.

2021 Road Program – *Small section of paving defect has been repaired by Glasgow under the Maintenance Bond.*

2022 Road Program – *A.F. Damon Inc. contract documents have been submitted to the Township and the Solicitor for review and execution.*

50 Dilworthtown Road Tree Harvesting Plan – *A review letter was issued on revised plans with items outstanding. Awaiting revised plans.*

Glen Mills Post Office – *A pre application meeting has been requested with PA DOT for proposed drainage improvements.*

ENGINEER'S REPORT
REGARDING WASTEWATER ISSUES
May 18, 2022

East Side District:

– Wet Weather Flows to WWTP

- KBX/Windriver has completed all work with the exception of the manhole inserts. The inserts have been ordered and will be installed when received.

– Isabella Lane Sanitary Sewer

- The low-pressure main and laterals have been installed/tested and the site has been restored. Various minor punch list items remain to be completed.

– Liquid Sludge Removal Contract

- We continue working with Russell Reid to obtain the revisions required to the insurance and bonding documents necessary for execution of the contract by the Township. We have been informed this information will be forwarded shortly.

– WWTP Improvements

- Executed documents along with insurance/bonding was received from Heisey on May 12th and is currently being reviewed.

East/West Side Districts:

– Manhole Rehabilitation

- Bids were received on May 6th. The low bidder was Advanced Rehabilitation Technology from Bryan Ohio with a base bid of \$74,718 and a base with all alternates of \$107,453. We have worked with Advanced Rehabilitation Technology in the past, and also have spoken with other municipalities that have used them for similar work. Both our experience and feedback from these municipalities was positive. In addition, we also reached out to Concord Township requesting that they consider contributing half of the cost for those manholes at the intersection of Route 1 and Brinton Lake Road where the Mill Road force main discharges.

West Side District:

– Mill Road Pump Station

- The new monitoring unit (OmniSite Crystal Ball) for this station was installed on Tuesday April 5th and is fully operational.
