Mr. O'Brien also noted a home on Natalie that also has a failing septic system. Mr. Jacquet reported sending the committee a copy of the sewer tie-ins for the West Side Sewer District. Only about 60 % have tied-in. If there is any significant change Mr. Jacquet will forward it. Mr. Morley asked about the availability of a design plan. Mr. Jacquet will obtain the plan from Mr. Faulkner and forward it to the committee. The members felt that except for parts of Carter, the remainder of BLC could use a gravity line, but it is more expensive.
