Thornbury Township Board of Supervisors Public Meeting Wednesday, August 18, 2021

The Thornbury Township Board of Supervisors held a Public Meeting, Wednesday August 18, 2021, hosted at the Township Administration Building, 6 Township Drive, Cheyney PA. Chairman Raith called the meeting to order at 7:03 p.m. with a salute to the flag.

APPROVAL OF CHECK REGISTERS

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, the General Fund check register in the amount of \$123,572.52, for the period July 22, through August 18, 2021, was approved. Chairman Raith called for comment. There was none.

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, the Sewer Fund check register in the amount of \$68,604.04, for the period July 22, through August 18, 2021, was approved. Chairman Raith called for comment. There was none.

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, the Sewer Expansion Fund check register in the amount of \$87.00, for the period July 22, through August 18, 2021, was approved. Chairman Raith called for comment. There was none.

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, the Capital Improvement Fund check register in the amount of \$9,090.85, for the period July 22, through August 18, 2021, was approved. Chairman Raith called for comment. There was none.

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, the Escrow Fund check register in the amount of \$2,500.00, for the period July 22, through August 18, 2021, was approved. Chairman Raith called for comment. There was none.

APPROVAL OF MINUTES

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, the Wednesday, July 21, 2021 Public meeting minutes were approved as presented. Chairman Raith called for comment. There was no comment.

SEWER ADVISORY COMMITTEE

Ted Jacquet had nothing to report.

ENVIRONMENTAL ADVISORY COUNCIL

No one from the EAC was in attendance. Jeff mentioned their Trees for Ten event in October and Art mentioned their Bat House project in Barrett's Meadow.

LIBRARY BOARD

Jean Mackenzie reported they received \$203,000.00 from the Wiley family and their plans for the Children's Library. She mentioned their half of the Keystone Grant has been met and she also attended Crabfest and had a great time.

AGENDA ITEMS

Mike Ciocco mentioned the Add Alternates to the 2021 Road Program.

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, ratifying the addition of all of Timber Lane (Alternate Bid items #1A & #1B) into the Thornbury Township Delaware County 2021 Road Program, offsetting the cost savings from the base repair not required on Glen Mills Road, was approved. Chairman Raith called for comment. There was none.

Mike Ciocco also mentioned final payments on the emergency repairs on Station Road.

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, ratifying final payment of 2 invoices to MOR Construction Services, Inc., in the total amount of \$9,090.85, for the Emergency Storm Sewer repairs on Station Road, in accordance with the Township Engineer's payment certificate dated July 31, 2021, was approved. Chairman Raith called for comment. There was none.

Chuck Faulkner reported on the Aeration Tank Painting Project.

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, payment No.2 to J.P. Smith Contractors, Inc. for the Aeration Tank Painting Contract, in the amount of \$43,442.60, in accordance with the Township Sewer Engineer's recommendation letter dated August 6, 2021, was approved. Chairman Raith called for comment. There was none.

Art Risley reported on the 2021-22 Salt Contract.

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, the 2021-22 Salt Contract with Eastern Salt Company, Inc., in accordance with the Delaware County Municipalities accepted bid at \$63.60 per ton, was approved. Chairman Raith called for comment. There was none.

Jeff Seagraves reported on the current Subdivision and Land Development extensions.

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, the extensions for the Daniels Subdivision from August 20, to November 18, 2021, the Lawlor Subdivision from August 30, to November 28, 2021, and the O'Kane Land Development from September 5, to December 4, 2021, were approved.

Jeff Seagraves reported on the need for the Treatment Plant pump replacement.

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, I move to approve the Proposal from Xylem Water Solutions USA, Inc., for the pump replacement at the Thornbury Township Wastewater Treatment Plant, at a cost not to exceed \$10,500.00, was approved. Chairman Raith called for comment. There was none.

Jeff Seagraves reported on the Cyber Security Proposal.

On a motion by James Kelly, seconded by Sheri Perkins, and carried unanimously, the Cyber Security Proposal dated August 3, 2021 from CYBIR, at a cost not to exceed \$160.00 per user, per year, and a flat fee of \$1,950.00 for a one-time Instructor Led Security Awareness Training Session, was approved. Chairman Raith called for comment. There was none.

Jeff Seagraves reported on the addition of Add Alternates to the Aeration Tank Contract.

On a motion by Sheri Perkins, seconded by James Kelly, and carried unanimously, the addition of all ADD Alternates for the Aeration Tank Painting Contract for an additional amount of \$133,745.00, bringing the contract total to a cost not to exceed \$305,315.00, on the condition that that the additional funding can be utilized from the American Rescue Plan Act of 2021, was approved. Chairman Raith called for comment. There was none.

PUBLIC COMMENT

- 1. Our Annual Crab fest was held on Friday, July 23, 2021, at 6:00 at Thornbury Park. It was our most well attended Crab fest thus far.
- 2. We are working on a list of priorities for projects to consider for the monies we received from DCED for the American Recovery Plan. I am recommending that we pay for the rehabilitation of the Aeration tank 1 and 2 from the ARPA monies and also approve accepting alternates #4 and #6 provided that we can pay for those alternates with the ARPA funds. (MOTION)

Township Solicitor, Kenneth D. Kynett Esquire, files the following report for August 18th, 2021:

1. Meeting Agenda New Reminder: Effective for all Township Board and Commission meetings beginning in September, meeting agendas are required to contain all items that will be voted on and be posted at the Township at least 24 hours before the meeting. Agendas must also be posted on the Township website and the Township Building and meeting place. Agendas must be available for the public at the meeting place. Unadvertised items may be added if agreed to by a majority vote of the Board or Commission. An explanation for changes to the advertised agenda must be announced before the vote the amended agenda must be posted on the Township website and at the Township Building no later than the first business day following the meeting at which the agenda was changed.

There are exceptions for: (1) emergency matters presenting a clear present danger to life or property; (2) *de minis* matters brought to the Board's or Committee's attention less than 24 hours before the meeting and which do not require expenditure of funds or the entry into contracts; and (3) matters brought up by residents or taxpayers, which may be referred to staff for follow up or acted on by the Board or Commission if they are *de minimis* in nature and do not require expenditure of funds or the entry into contracts.

Following discussions with the Township Manager, a new "Action Item Add On" agenda item (similar to a call for public comment), will be added to meeting agendas to allow the Boards and Commissions to determine if there are additional agenda items needing action and appropriately address those items on a meeting by meeting basis as the need may arise.

- 2. <u>35 Locksley Road Zoning Violation</u> Zoning Hearing Board met and rendered a decision on August 2, 2021, denying the appeal of the zoning violation, as well as the application for alternate relief seeking a variance, special exception and/or conditional use. The Applicant has 30 days (September 1, 2021) to appeal the Zoning Hearing Board's decision.
- 3. <u>Guilday Creek Road Subdivision Sewer Dedication</u> Working with Township and Developers to secure dedication of *public portion* of sanitary sewer facilities constructed and installed in connection with this development.
- 4. <u>Black Bell Farm Dedication</u> Continue to work with Developer's Counsel on legal side of dedication.



REPORT OF THE ENGINEER August Supervisor's Meeting August 18, 2021

Work completed for the period:

Grading and Road Encroachment Permits – Reviewed several plans for grading and road encroachment. Construction inspections continue.

Planning Commission – Continued working with members on Ordinances and Subdivisions.

Subdivision & Land Development Plans:

Lawler Subdivision - Awaiting revised plans.

Daniels Subdivision – 425 Thornton Rd – 2 Lots – Conditional Final approval granted in 2016. Awaiting updated recording plans and agreements for signature.

15 Tanguy Road – 2,400 SF Accessory Structure Land Development – Revised plans received in late June, and updated review issued. Applicant requested PC to table review again for August and review in September when they have some more information.

VMDT – Dilworthtown Road – Reviewed Zoning paperwork with Township Officials. Awaiting Subdivision / Land Development submission for complete review.

Ordinances:

Sign Ordinance – PC forwarded ordinance to the Supervisors for consideration.

Plant Materials List – Reviewed current Township Ordinance Plant Materials List and issued our Landscape Architect's recommendations for exclusions due to local blights and diseases. Reviewed with the Planning Commission in May. PC forwarded list changes to the Supervisors for consideration.

Crane Property – 24 Lot Subdivision – Work continues on multiple home lots. Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 13, 14, 15, 16, 17, 18, 19, 20, 21, 23, & 24 homes are now occupied. House construction continues on Lots 12 & 22. Review of conversion of existing temporary CO's to Permanent CO's are ongoing.

Black Bell Farm (Walton Lane) – 15 lot subdivision – Lots 1-14 (All new homes) are now occupied. Per developer's request, an updated Punch List was issued on 5-7-2021 (originally issued 7-23-2020). Partial Paperwork just started coming in for dedication and is under review. Roadway repairs and final paving completed week of 8/9/21. Awaiting final correction of punch list deficiencies and completion of dedication paperwork submission.

Guilday Site – Lots 1-5 houses are occupied with Temporary CO's. Request for final inspection received in June and a Final Punch list was issued to the developer on 7-15-2021. Awaiting corrections and closeout paperwork.

Sunoco Logistics – Sunoco has completed all piping and valve work. Awaiting Final Restoration and request for final inspection.

NPDES MS-4 Program – 2018 Pollutant Reduction Plan and 2018 MS-4 permit submitted on September 9, 2017 & September 15, 2017, respectively. Continuing to work with PA DEP on revisions. Detailed updates to the storm sewer and qualifying watershed mapping has been completed to comply with revision requests from PA DEP. Program is currently under Township review prior to resubmission of mapping.

Thornbury Park Rain Garden – Water Quality Improvement Project Grant – PA DEP Grant work must be completed by December 31, 2021. Project is substantially complete. Sign design sent to sign contractor/supplier for review and completion. Meeting set with contractor to review final items for closeout.

Emergency Repairs – Station Road – Emergency storm sewer repairs are all substantially completed.

• Partial payment of 2 invoices recommended to MOR Construction in the amount of \$9,090.85.

Thornbury Pre-School Roof Replacement – Draft plans prepared for slate or synthetic slate alternate bidding. Submitted to Township officials for review and comment.

Terra Firma Builders – 53-57 Sweetwater Road – Coordination with the Township and applicant on final closeout paperwork and bonding requirements ongoing.

Township Map Update – Working with Township officials to update the Township Map with new subdivisions and overall map corrections.

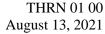
Salt Shed Structural Evaluation – Coordination ongoing with Township Roadmaster and structural engineer for the structural evaluation of the Township Salt Shed in Thornbury Park.

2021 Road Program – Glasgow completed milling and paving of the base bid and the Timber Lane Alternate, which was able to be added due to cost savings from base repair that was not actually required in the base bid.

2021 Additional Paving Projects – Awarded to Glasgow Inc. for Base Bid and Alts A. Contracts were executed and Contractor tentatively scheduled for mid-October start, due to delay in stormwater material availability.

Various Drainage Improvement Projects – Prepared sketch plans and began discussion with Township officials on various drainage improvement projects throughout the Township.

Snow & Ice Contracts – 2 Bids received and opened on June 9, 2021. MOR Construction has been notified of award and request for Bonds and contract document signature pages have been sent out.





ENGINEER'S REPORT REGARDING WASTEWATER ISSUES August 18, 2021

East Side District

- Wet Weather Flows to WWTP

• Smoke testing of the sewer within the easement between the properties on Country Run and Thornton Road is scheduled for Thursday August 19th. This area is low-lying wet area where leaks have been identified previously. The work is limited to the section from the WWTP south to approximately 458 Thornton Road; a total of seven (7) runs of sewer with only two (2) lateral connections. Notification letters are being sent out to the immediate property owners in the vicinity of the testing.

- Painting of Aeration Tank 1&2 @ WWTP

• The first half of the overall tank was completed and put back in service on August 2nd. This half had a significant amount of repair work, particularly on the floor where a considerable amount of pitting was present around the location of the aerators. Work is currently underway on the second half of the tank. The condition of this side is much better than the other half. Although there is some pitting on the floors and walls, the degree and severity is considerably less. Given favorable weather, this half will likely be completed within the next 1 to 2-weeks.

- Black Bell Farm

• A punch list letter was forwarded to the Developer on August 13th. Only four minor items remain; three of which are associated with revisions to the as-built plans.

West Side District

- Wawa- Dilworthtown Road and Route 202

• We met with Matt Kesling of Wawa on August 2nd to review the issues that caused the July 7th SSO at this store. According to Matt, several issues including a pump seal failure, a failing transducer and a potential clog in their section of force main contributed to the problem. These issues have been resolved according to Matt. We also discussed the need for a timelier response to such emergencies by Wawa including such things as the connection of the auto-dialer and the repair of the visual alarm beacon. Finally, we are soliciting pricing to flush the entire length of the 2-inch main from Wawa to the discharge point in the Cherry Creek development. Wawa has indicated they will share in the cost for this work.
