

## **HEARING MINUTES**

Thornbury Township Board of Supervisors Hearing Wednesday, October 20, 2021

The Board of Supervisors held a Public Hearing on October 20, 2021 for the adoption of Ordinance No. 1 of 2021.

"AN ORDINANCE OF THORNBURY TOWNSHIP, DELAWARE COUNTY, AMENDING CHAPTER 1, ARTICLE 2, OF THE THORNBURY TOWNSHIP CODE OF ORDINANCES, BOARDS, COMMISSIONS AND APPOINTED OFFICIALS, BY ADDING NEW SUBSECTION F, BOARD OF HEALTH, AND SECTIONS 1-251—1-256 TO REFLECT THE CREATION OF THORNBURY TOWNSHIP BOARD OF HEALTH AND ESTABLISH HEALTH AND SANITATION REGULATIONS FOR ENFORCEMENT BY THE THORNBURY TOWNSHIP BOARD OF HEALTH THROUGH THE HEALTH OFFICER AND INSPECTORS AND OTHERS; PROVIDE FOR ENTRY ONTO TOWNSHIP PROPERTIES IN CONNECTION THEREWITH; ALLOW FOR MUNICIPAL COOPERATION AND UTILIZATION OF STATE RESOURCES; AND TO PROVIDE PENALTIES FOR THE VIOLATION OF SUCH REGULATIONS."
