

## **ORDINANCE HEARING MINUTES**

Thornbury Township Board of Supervisors Hearing Wednesday, September 21, 2022

The Board of Supervisors held a public hearing on September 21, 2022 for the adoption of proposed Ordinance 3 of 2022 "Stormwater Ordinance Amendment".

AN ORDINANCE AMENDING THE THORNBURY TOWNSHIP CODE OF ORDINANCES, CHAPTER 19, STORMWATER MANAGEMENT, TO IMPLEMENT CERTAIN STORMWATER MANAGEMENT CHANGES AND UPDATES AS REQUIRED TO COMPLY WITH (1) THE REGULATORY REQUIREMENTS OF THE PENNSYLVANIA DEPARTMENT OF ENVIRONMENTAL PROTECTION NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PROGRAM AND (2) THE PROVISIONS INCLUDED IN DEPARTMENT'S 2022 MODEL STORMWATER ORDINANCE.

Chairman Kelly then opened the hearing at 7:00 PM and introduced the Township Solicitor, Mr. Kenneth Kynett, Esq., who entered several items as exhibits and gave an overview detailing the ordinance. Solicitor Kynett entered the following items as exhibits:

Ken explained the Chapter 19 Stormwater Ordinance sets forth a comprehensive scheme of stormwater management for properties located within Township; and the Pennsylvania Department of Environmental Protection has mandated that the Board of Supervisors revise Chapter 19 Stormwater, to comply with the regulatory requirements of the Department's National Pollutant Discharge Elimination System, Municipal Separate Storm Sewer System (MS4) Program, through the adoption of provisions of the Department's

2022 Model Stormwater Ordinance. It updates Chapter 19 by update some provisions and regulations. They will be applicable to zoning and through the Subdivision and Land Development Ordinance. Chairman Kelly asked if this amends what we have now, and Ken answered yes. Chairman Kelly then asked the Board first for any comment. Supervisor Mike Mattson thanked Ken for putting this together under a tight deadline. The Chairman then asked the public. Ted Jacquet asked if it affects residents and Chairman Kelly explained the simplified method. Barbara lacovelli asked if it changes zoning and Ken explained subdivision and land development and it will not affect her property.

Chairman Kelly closed the hearing at 7:06 PM.
